



## FINANCIAL AGREEMENT TUITION EXPRESS

On this \_\_\_ day of \_\_\_\_\_ 20 \_\_, I, \_\_\_\_\_ have been fully advised of the services offered by Kids Kingdom Child Care and Learning Center (KKCCLC). I also understand that services are available from 6:30 a.m. to 6:30 p.m., Monday through Friday (excluding holidays and snow day). I do hereby enroll my son/daughter \_\_\_\_\_ into KKCCLC for their services. As compensation of these services I agree to pay:

- A one-time ONE week deposit of \$ \_\_\_\_\_00.
- A one-time NON-REFUNDABLE registration fee of \$100.00, and
- An automatic ACH Payment of \$ \_\_\_\_\_00 one week in advance of the care needed.

I understand that KKCCLC reserves the right to increase the weekly tuition at any time. Should this change occur a four week written notice will be given to the parent in advance. If my child's tuition is received after the close of business Monday, my account will be charged \$10.00 for each day that the account remains past due.

I will receive no credit, discount or refund due to center holidays, snow days, acts of God, inclement weather, sick days or parent/child vacation time. I understand that the center closes at 6:30 p.m. and there is a late pick-up fee of \$3.00 per minute. This fee will be credited to my account and will be pulled with the following ACH payment.

I understand that I will be required to pay my child's initial fees in the form of a money order, or certified bank check. All payments (i.e. tuition, late fees, pictures, field trips, etc.) will be deducted via my KKCCLC Tuition Express account. If an electronic payment is returned NSF, I understand that I will be charged a \$35.00 return payment fee. Should there be an accidental draw on my account by KKCCLC, I will be reimbursed the amount of the accidental draw. Should my bank account be charged an overdraft fee due to this draw, then I shall be reimbursed a maximum of \$35.00.

I understand that KKCCLC reserves the right to dismiss my child from the program for any valid reason with a two week written notice. Should I decide to withdraw my child from KKCCLC, I am required to give a two week written notification (with the week beginning on a Monday). I understand my one week deposit will be credited to my child's final week in the program. If no written notice is given, then I understand that I will be responsible for one week of service and will forfeit my one week deposit. NO refunds of deposit or tuition will be given.

It is my responsibility to cancel any third party payments in a timely fashion. Should there be any additional residual third party payments (i.e. NACCRRA, FEAA, etc) I will receive no refund.

Should my account incur a one week past due balance, I understand that services will be automatically suspended and that my one week deposit will be applied to my past due balance. Should there still be a remaining balance due and KKCCLC turns my account over to a collection agency, I agree to pay all back tuition and a 50% collection fee of the total.
